## **SOCIAL MEDIA POLICY**

When using all forms of Social Media, all parents, students, teachers, and assistant teachers must adhere to The Elizabeth School of Dance Social Media Policy.

For the purpose of this document, the word “teacher” refers to fully qualified ESOD teachers, trainee assistant teachers and class assistants.

- Students and parents may not photograph, video or record any material in classes/ rehearsals without the teacher's permission.
- Where permission has been given to record a class/routine for rehearsal purposes, use of that recording has been authorised for that purpose only and must not be posted on any Social Media platform. The only exception being, where there is a closed/private group that has been authorised by the class teacher to be used for the same rehearsal purposes.
- No footage of The Elizabeth School of Dance performances are to be shared to Social Media without permission from The Elizabeth School of Dance.
- Students under the age of 18 must not contact their class teacher for any queries via any communication platform without written consent from their parent/ guardian.
- We discourage all teachers from accepting any student of the school (current or ex) under the age of 18 as a friend, follower or subscriber or similar on any personal social media account unless there is an existing relationship.
- Students/Parents are not authorised to contact The Elizabeth School of Dance staff publicly via their personal Social Media account(s) at any time or for any reason. Should a teacher be contacted, it is their duty to let staff of The Elizabeth School of Dance know so it can be monitored. Class teachers can be contacted by parents privately via their personal social media accounts only when dance related or alternatively (and the preferred option), please phone/text the teacher direct or email via the school email address – [info@elizabethschoolofdance.com](mailto:info@elizabethschoolofdance.com). Students may not contact teachers on their private social media accounts. (Excludes authorised facebook/Whatsapp groups)
- Personal Social Media accounts are not to be used publicly to communicate attendance, queries, or any other administrative information, this must be done through the school email address, private messaging via social media or the relevant closed group or phone.
